The Architectural Review Board reviewed an application from the owners of the building to remove the existing tenants sign and replace with a new tenant sign. The sign is to be centered between two exterior lights and the CORE business sign is likely to be removed in February, 2024.

- Member Lovett moved to approve the application with the condition that the CORE business sign, arrow sign, and other business plaques be removed, and with the understanding that the small signs currently posted in the rear of the building may remain as is, and the Fullerton & Knowles directional sign will be affixed to the door, seconded by Member Yantis. The motion was approved by poll, 4-0.

 - a. 12644 Chapel Road | Request for Guidance (Farmer's Market).


The Architectural Review Board reviewed an informal list of signage ideas from The Fruitful Forest, LLC for the 2024 season of the Farmer's Market.
